This is to inform all members that the official website of the 8th Central Pay Commission has been launched for inviting suggestions and recommendations from stakeholders. The Commission has provided an opportunity for **Central Government Employees, Institutions, Associations, and Individuals** to submit their valuable suggestions, views, and recommendations regarding pay structure, allowances, service conditions, and other related matters.

AIAMSWP family Members are encouraged to actively participate in this important consultative process and submit their suggestions through the official website only. Before submitting your suggestions to the 8th Central Pay Commission through its official website (<https://8cpc.gov.in/>), kindly take note of the following important points:

#### □ Key Points to Understand:

- Online Mode Only:** Suggestions will be accepted **only through the online mode** available on the official website.
- No Hard Copies / Email Submissions:**  
The Commission will **NOT accept** any hard copies, email submissions, PDF attachments, or any other offline mode of communication. Only submissions made through the official portal will be considered.
- 18 Questionnaire-Based General Suggestions Invited:**  
At present, the Commission has invited responses to **18 questionnaire-based general suggestions**, which may be submitted by anyone through OTP-based login.
- Submission Through MyGov Portal:**  
All responses to the 18 questionnaire-based questions must be submitted through the official **MyGov portal**.

- Last Date for Submission:**  
The last date for submission of responses to the 18 questions is **Monday, 16th March 2026**. Members are requested to complete their submissions well before the deadline.
- OTP-Based Login Required:**  
Submission requires **OTP-based authentication login** on the MyGov portal. Members must complete the login process to submit their responses.
- Detailed Memorandum Submission (To Be Opened Soon):**  
The link for submitting a **detailed memorandum** will be made available separately on the website of the 8th CPC in due course. Members are advised to regularly check the official website for updates regarding this facility.
- AIAMSWP (Association-Level) Compiled Representation:**  
Members are requested to carefully review all 18 questions. After thorough consideration, they may **forward their suggested responses for respective questions to the General Secretary, AIAMSWP through email at [gsaiamswp@gmail.com](mailto:gsaiamswp@gmail.com) till 28<sup>th</sup> February, 2026**. Based on members' inputs, AIAMSWP will prepare and submit a compiled and consolidated representation from the Association's side.
